

**NOTIFICATION OF INTENT TO BECOME A REGISTERED RECEIVER OF
ROCK LOBSTER-
WEST COAST ROCK LOBSTER MANAGED FISHERY**

This form is to be used by a person intending to register as a Registered Receiver for the purpose of receiving lobsters from the master of an authorised boat operating under a West Coast Rock Lobster Managed Fishery licence.

It is a requirement of a notification of intent to nominate the premises where the rock lobster received will be weighed and removed from sealed and tagged containers, in accordance with the *West Coast Rock Lobster Management Plan 2012*.

The premises to be specified on a certificate must be a building, structure, edifice, or otherwise attached to land.

A registered receiver must inform the Chief Executive Officer in writing if they cease to operate as a registered receiver.

The registered receiver is to keep the certificate of registration at the registered receiver's premises.

The holder of a Fish Processor's Licence, authorising the holder to process rock lobster, is held to be a registered receiver, subject to the issue of a registered receiver certificate by the CEO and need not complete the notification form.

A person who holds a Commercial Fishing License cannot register as a registered receiver or act for or on behalf of a registered receiver, subject to the *West Coast Rock Lobster Management Plan 2012*.

The notification form can be forwarded to the Department of Fisheries at the address listed at the top of the Form.

Instructions for completing this Form

Please use block letters when completing this Form.

PART A

- 1. Notification** - specify the full name, business address, postal address and email address (if applicable). If a corporation, print the Australian Company Number ('ACN') and the Australian Business Number ("ABN") after the name. Specify the business hours telephone and facsimile numbers.

PART B

2. Receiver Premises-

Show details of the:

- 2.1** Address of receiver premises (Lot No. or location description) where rock lobster are received, weighed, and removed from secured and tagged containers.

Note: Receiver premises must be fixed and cannot be a vehicle, trailer, caravan, boat or other moveable object.

3. Disclosure of Name and Contact Details-

Your name and contact details are stored on the Department of Fisheries Licensing and Management System. From time-to-time requests from industry participants and stakeholders are received (ie. representative bodies such as Western Australian Fishing Industry Council, fishermen, fish processors, registered receivers of rock lobster and fish retailers) to provide them with name and contact information. Your consent to disclose your details is required. The Department retains the right not to release your personal information.

4. Notifier's Declaration

Note there are penalties under the *Fish Resources Management Act 1994* for making false or misleading statements in an application.

5. Execution of Notification -

- 5.1 Signatures** - if the certificate is to be held by more than one person, then all persons to be named on the certificate must sign and date this notification.
- 5.2 Corporation** - if the proposed registered receiver is a corporation, the notification form must be signed and sealed in accordance with the sealing clause of the corporation's Articles of Association.
- 5.3 Attorney** - if the proposed register receiver has appointed an Attorney, the Attorney signing may be requested to produce the relevant Power of Attorney instrument for viewing and a copy for recording.
